04. FIRST – AID MEASURES

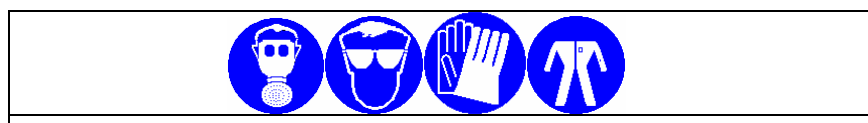
